- (g) to maintain records in respect of the apprentice on such matters as time worked, wages, travel and subsistence paid and to keep any records required by the authority in respect of the apprentice;
- (h) to make available to the apprentice the requisite tool and materials for the work which the apprentice will be engaged on if these tools are in excess of the tools prescribed by NTPC and all necessary educational text books and drawing instruments;
- to advance monies to the apprentice for the purchase of tools prescribed by NTPC and recover these monies, less any tool allowance from NTPC, from the apprentice in accordance with section 51 of the Employment Ordinance;
- (j) not to require or permit the apprentice work such hours as would necessitate the apprentice being absent from a day, evening or night related to educational classes;
- (k) not to permit the apprentice if under eighteen years of age to work more than twenty hours overtime in any one month without prior approval from NTPC;
- (l) not to permit the apprentice to work outside Fiji without prior written permission of NTPC;
- (m) not to engage more than the number of apprentices for which the written approval of NTPC has been obtained;
- (n) to apply for NTPC's permission to employ the apprentice and shall register the apprentice with NTPC within three months from engaging the person as an apprentice;
- (o) not to request or to accept a premium in respect of the employment of the apprentice;
- (p) to inform NTPC, as soon as possible, if he is or will be unable to provide employment or suitable training or the established apprentice and if such be the case he shall if required, facilitate the apprentice's transfer on a temporary or permanent basis;
- (q) to furnish an original recent medical certificate with the contract;
- (r) to undertake to pay the apprentice wages not less than the rates in the apprenticeship Minimum Wages Order and such travelling and subsistence allowance as NTPC may determine.

The minimum wage rates applying at the date of commencement of this Contract are:-

for the 1<sup>st</sup> year of apprenticeship **\$.....** cents per hour for the 2<sup>nd</sup> year of apprenticeship **\$.....** cents per hour for the 3<sup>rd</sup> year of apprenticeship **\$.....** cents per hour for the 4<sup>th</sup> year of apprenticeship **\$.....** cents per hour for the 5<sup>th</sup> year of apprenticeship ...... cents per hour

#### 3. THAT NTPC AGREES:

to exercise its powers under the provisions of the Fiji National University (Amendment) Decree 2010

- (i) to undertake, where possible, to ensure that training is provided for the duration of the apprenticeship agreement for the apprentice if the employer ceases to be engaged in the relevant trade or occupation;
- (ii) to register the apprentice in its records and to inform the employer and apprentice accordingly;
- (iii) to shorten the period of the Agreement if it thinks fit in exceptional circumstances;
- (iv) to issue completion certificate at the end of the apprenticeship.

**4.** This Contract shall be subject to the Provisions of the Fiji National University (Amendment) Decree 2010 that covers the Apprenticeship Scheme and Training Recommendations published under Ministerial Order relating to Apprenticeship in general or to the designated field to which this Contract refers.
